Brief on context to PDSE's environmental objectives

PDSE's vision is to provide excellent primary dental care services to our communities, while providing the best clinical placement facilities for dental students of any UK dental school.

While going about delivering on this vision, Sustainability represents one of PDSE's core organisational values.

These environmental objectives set a clear determination of PDSE's commitment regarding its environmental performance and associated impacts.



PDSE Environmental Objectives

PDSE has established these environmental objectives in respect to the nature and scale of our environmental impacts.

The objectives are communicated to employees on joining the organisation and at regular intervals thereafter and have the commitment of top management to ensure appropriate resources and facilitation across the organisation to permit their achievement.

1. **GHG emissions:**
 - a. Achieving Net Zero in Scope 1 and 2 emissions by 2040 (location-based reporting)
 - b. An interim reduction in Scope 1 and 2 emissions of 45% by FY29-30 compared to FY21-22
 - c. Achieving Net Zero in Scope 3 emissions by 2050
2. **Energy management:**
 - a. Reducing energy use of facilities per patient appointment at least 25% by 2050 compared to FY21-22
3. **Water management:**
 - a. Reducing water use of facilities at least 25% by 2030 compared to FY21-22
4. **Waste management:**
 - a. Achieving an 80:20 ratio on offensive waste:clinical infectious waste as generated in our clinical settings
 - b. Reducing the overall mass of waste generated per patient appointment by 20% by 2030 compared to FY24-25
5. **Travel and transport:**
 - a. Achieving a reduction of 45% in business travel emissions by 2030 compared to FY24-25
 - b. Achieving a reduction in commuting to work emissions of 45% by 2030 compared to FY24-25
 - c. Achieving a 45% reduction in the GHG emissions of PDSE's inter-site courier services by 2030
6. **Procurement and construction:**
 - a. Launching an on-going programme of supplier engagement, starting with suppliers understood to have highest GHG emissions of goods & services provided and working with each to reduce impacts of service delivery
 - b. Launching an on-going programme of consumables replacement (or removal) with those with lower associated environmental impacts
 - c. Achieving BREAM 'Very Good' on relevant new build construction and 'SKA Gold' on relevant refurbishment works, for newly conceived projects
7. **Education:**
 - a. Empowering PDSE employees to take Environmental Sustainability informed decisions in going about their work
 - b. Leveraging our learnings from our EMS to enrich the University of Plymouth's teaching of Sustainability in dentistry
 - c. Doubling the number of people engaged through our outreach work compared to 23-24 by 2030
 - d. Realising our potential to be a leader, facilitator and accelerant of the transition to Sustainable dentistry
8. **Biodiversity:**
 - a. Improving grounds maintenance practices to be more conducive to biodiversity at each site by FY25-26
 - b. Creating new or expanding existing ecologically rich habitats at each of our sites by 2030
9. **Ethical investment:**
 - a. Achieving MSCI/Sustainalytics rating of 'BBB' (minimum) by FY26-27 for any banks or investment funds used

As per the requirements of ISO14001:2015 the nature of objectives will be reviewed from time-to-time, to ensure their continued relevance to the organisation's evolving impacts.
